Our history

The John Schofield Trust was founded in 1996 by the family and friends of John Schofield, a young journalist who was killed whilst reporting on the war in Croatia for the BBC. John's widow, Susie Schofield MBE, remains heavily involved in the charity today, as do many of his friends and colleagues.

We enjoy wide support from the sector, with many of the media organisations funding our activities and a range of journalists mentoring for us.

Our activities

Early career and apprentice scheme

Our most well-known programme supports journalists who have two to five years' experience in the sector by pairing them with an experienced journalist for 12 months of mentoring support and networking.

Students of journalism

We are partnered with 11 universities and offer individual mentoring to a cohort of students from each.

Emerging young talent of the year award

Since 1996, we offer an annual award to recognise young journalists in conjunction with the Royal Television Society.

Masterclasses and networking

We host in-person or virtual events on a monthly basis for the

whole network.

Expectatations

As a trustee, you will:

- Attend at least five meetings per year, mostly remotely, with at least one in-person away day per year.
- Play a vital role in shaping the Trust's future strategy and growth.
- Provide expert guidance, and support the Trust's staff and beneficiaries.
- Contribute to a collaborative and rewarding board environment.
- The role is unpaid and voluntary. The Trust will cover all reasonable expenses to attend meetings and events.

The normal term for a trustee is three years, with the possibility of an extension after that point.
